MINIMUM QUALIFICATIONS:

- Currently enrolled at the University of Guam;
- Strong science background (e.g. completed coursework in calculus, physics, chemistry, biology, earth science, life science, economics, differential equations, numerical analysis, computer programming skills, and Geographic Information System (GIS) remote sensing)

NECESSARY QUALIFICATION:

Must have a valid Guam Driver's License

QUALIFICATIONS REQUIRED: Pursuant to Public Law 26-87 as amended by Public Law 29-113, all future employees of any position within the government of Guam will be required at minimum to possess one of the following:

- 1. A high school diploma; or
- 2. Successful completion of General Education Development (GED) Test; or
- 3. The equivalent of a general education high school program; or
- 4. Successful completion of a certification program, from a recognized accredited or certified vocational technical institution, in a specialized field for the job.

DUTIES AND RESPONSIBILITIES:

Under the direct supervision of the Guam Hydrologic Survey (GHS) Research Associate, the Research Assistant I will assist Water and Environmental Research Institute (WERI) researchers with the on-going projects titled: Guam Hydrologic Survey (GHS) and Comprehensive Water Monitoring Program (CWMP). Duties include: 1) acquiring, compiling and organizing hydrogeologic data, and uploading the data to the GHS website, 2) maintaining field equipment, lab and storage 3) conducting field works with the researchers in survey, sampling, equipment installation, and data collection, and 4) assisting the researchers in analyzing the data, preparing charts and graphs, and producing and disseminating WERI technical reports. Hours are flexible, but applicants must be prepared to meet field and meeting schedules, which are subject to change on short notice.

EDUCATION:

Applicants claiming degree or credit hours are required to provide an original or certified copy of the documents (e.g., transcripts, high school diploma, or GED certification) accompany the application.

WORK ELIGIBILITY:

Submission of completed job applications authorizes the University of Guam to seek and obtain information regarding the applicant's suitability for employment. All factors which are job related may be investigated (i.e., previous employment, educational credentials, and criminal records). All information obtained may be used to determine the applicant's eligibility for employment in accordance with equal employment opportunity guidelines. In addition, the applicant releases previous employers and job-related sources from legal liability for the information provided.

Section 25103, Chapter 25, Title 10 of the Guam Code Annotated requires college or university employees to undergo a physical examination, to include a test for tuberculosis (skin or x-ray), prior to employment and at least

annually thereafter. A report of such examination must be conducted by a licensed physician within a state or territory of the United States and must be submitted upon request.

Federal law requires presentation of eligibility to work in the United States within seventy-two (72) hours of reporting for employment. Specifically, 8 USC 1324A requires the employer to verify the identity and eligibility to work in the United States of all newly hired employees. The University of Guam is required to comply with this law on a non-discriminatory basis. If you are hired to fill a position within the University of Guam, you will be required to present valid documents to comply with the law.

POLICE AND COURT CLEARANCE:

Pursuant to Public Law No. 28-24 and Executive Order 2005-34, applicants selected for a position are required to provide original police and court (Superior Court of Guam) clearances of no more than three (3) months old prior to commencement of employment. Off-island applicants must obtain clearances from their place of residence. Applicants are responsible for fees associated with obtaining the clearances.
