#### **MINIMUM QUALIFICATIONS:**

- Master's degree from a U.S. accredited institution or foreign equivalent in a discipline related to disabilities (psychology, special education, rehabilitation, or a related field); and
- A minimum of twelve (12) years of demonstrated experience in the field of disabilities.

#### **NECESSARY SPECIAL QUALIFICATION:**

• Must have a valid Driver's License.

#### PREFERRED QUALIFICATION:

• PhD or equivalent (i.e., PsyD, DrPH, JD, MD, EdD) from a U.S. accredited institution or foreign equivalent.

#### **QUALIFICATIONS REQUIRED:**

Pursuant to Public Law 26-87 as amended by Public Law 29-113, all future employees of any position within the government of Guam will be required at minimum to possess one of the following:

- 1. A high school diploma; or
- 2. Successful completion of General Education Development (GED) Test; or
- 3. The equivalent of a general education high school program; or
- 4. Successful completion of a certification program, from a recognized accredited or certified vocational technical institution, in a specialized field for the job.

#### KNOWLEDGE, ABILITIES, AND/OR SKILLS:

Knowledge of interdisciplinary training programs supportive of individuals with disabilities and their families. Knowledge of administrative leadership effectiveness including exemplary interpersonal, oral and written communication skills. Ability to demonstrate an understanding of organizations. Ability to facilitate efforts to secure external funding such as grants and contracts. Ability to demonstrate expertise in training, service and technical assistance, research and dissemination. Ability to network with local, regional, and national levels to access resources and nationally recognized consultants. Expertise in working with faculty across different disciplines. Expertise in conflict resolution strategies. Expertise in the field of disabilities. Extensive administrative and supervisory experience in an organization with a programmatic focus that includes individuals with disabilities and their families. Knowledge of principles of multimedia product development. Knowledge of use of technology for communication, administration and education. Knowledge of principles of marketing. Knowledge of principles of graphic design, print, video and audio product development.

#### **CHARACTER OF DUTIES:**

funding in areas that promote independence and integration into the community of individuals with disabilities and their family members. Administers projects when awarded. Promotes relationships with agencies, businesses/industry and community organizations to support the mission of the center. Represents the center, its mission and functions as appropriate on boards, committees, and councils at the university, local, regional and national levels. Participates in advocacy to support independence and integration into the community of individuals with disabilities at the local, regional and national levels. Serves as Acting Director in the absence of the UOG CEDDERS Director, when needed. Oversees the development and dissemination of developed products such as newsletters, brochures, posters, videos and audio products to ensure that internal standards are met. Performs related duties as required that support UOG CEDDERS and the UOG mission. Attends UOG CEDDERS monthly staff meetings, quarterly Advisory Council meetings, quarterly and other strategic planning meetings. Facilitates the reporting of UOG CEDDERS data to the National Information Reporting System. Facilitates the completion and submittal of an annual report to the Administration on Developmental Disabilities. The work environment, including the general work atmosphere and setting for this position is within the UOG CEDDERS offices/buildings. Events may be held on evenings and weekends. The work setting may change to off-site locations, i.e., a government agency or other facility, which may require the individual to visit off-island sites where CEDDERS provides contractual or grant funded services/activities.

#### **EDUCATION:**

Applicants claiming degrees or credit hours are required to upload a certified copy of the documents (e.g., transcripts, high school diploma, or GED certification) with the online job application through UOG's online employment portal at <a href="https://uog.peopleadmin.com">https://uog.peopleadmin.com</a>.

#### **WORK ELIGIBILITY:**

Submission of completed job applications authorizes the University of Guam to seek and obtain information regarding the applicant's suitability for employment. All factors which are job-related may be investigated (i.e., previous employment, educational credentials, and criminal records). All information obtained may be used to determine the applicant's eligibility for employment in accordance with equal employment opportunity guidelines. In addition, the applicant releases previous employers and job-related sources from legal liability for the information provided.

Section 25103, Chapter 25, Title 10 of the Guam Code Annotated requires college or university employees to undergo a physical examination, to include a test for tuberculosis (skin or x-ray), prior to employment and at least annually thereafter. A report of such examination must be conducted by a licensed physician within a state or territory of the United States and must be submitted upon request.

Federal law requires presentation of eligibility to work in the United States within seventy-two (72) hours of the date reporting for employment. Specifically, 8 USC 1324A requires the employer to verify the identity and eligibility to work in the United States of all newly hired employees. The University of Guam is required to comply with this law on a non-discriminatory basis. If you are hired to fill a position within the University of Guam, you will be required to present valid documents to comply with the law.

#### POLICE AND COURT CLEARANCE:

Pursuant to Public Law No. 28-24 and Executive Order No. 2005-34, applicants selected for a position are required to provide original police and court (Superior Court of Guam) clearances of no more than three (3) months old prior to commencement of employment. Off-island applicants must obtain clearances from their place of residence. Applicants are responsible for fees associated with obtaining the clearances.
